7. AGENDA ITEMS

General Manager's Update (Russell Cole)

- There have been ongoing cost reviews since December 2012 including a hiring freeze.
- 14 redundancies were made in July.
- Other cost cutting initiatives include removal of non essentials including projects, catering and reviews of commercial agreements.
- KCGM have also implemented staff-led initiatives including switching to long life milk, team BBQ's cancelled and new printing software.
- Aiming to reduce cost per ounce to \$1,000.
- Community investment will primarily be focused on KCGM's, ongoing commitment to Hannans North and other sponsorships and donations will be reduced.
- Physical prediction to end of 2013:
 - Open pits on schedule for tonnes moved, though will be behind in ore tonnes.
 - Mount Charlotte will be ahead of budget.
 - Processing will be ahead in tonnes milled, however grade slightly behind.
 - Overall our recovered ounces and shipped ounces are currently looking good.

2013 Annual SGMP Audit (Janine Cameron / Orla Tone)

- The Seepage and Ground Water Management Plan (SGMP), covers how KCGM manages seepage from the Fimiston and Kaltails Tailings Storage Facilities (TSFs).
- Each year an independent auditor reviews the SGMP.
- The CRG was asked to review the report and provide feedback, to be incorporated into the final report.
- The audit identified one area for improvement:
 - The Kaltails supernatant pool size was found to be over the operational target of 15% several times during the audit period. This is due to increased rainfall and pump faults. The slightly larger pool size has not significantly impacted on seepage and groundwater management.

Social Responsibility (Jacqui Niemand) Activities in July:

- Hannans North visitors in July included the WA Policy Legacy Camp, ABC film crew and over 810 visitors through Goldrush Tours.
- Hannans North visitor numbers have increased and shop proceeds are almost double compared to the same time last year
- Mt Charlotte 50 years birthday celebration tours are being held throughout September and October.
- 68 media reports in July; 6 positive, 62 neutral and 0 negative.
- 3 Donations and 1 Sponsorship approved in July with a total value of \$8,591. 3 year agreement with St Barbara's Festival being developed.
- KCGM recorded 35 public interactions, including 4 complaints: SO₂(3), and Noise (1).
