7. AGENDA ITEMS

General Manager's Update (Tim Berryman)

- Operations are tracking well.
- Russell Cole is currently in Papua New Guinea visiting the Porgera mine site.

Environment Reporting (Michelle Berryman)

- Cyanide Code:
 - An overview of cyanide chemistry, risks (environment and health effects) and use in gold mining was presented for discussion.
 - In 2005, the International Cyanide Code for the Manufacture, Transport and Use of Cyanide in the Production of Gold was developed. This is a voluntary program for gold mining companies.
 - Each operation is audited by an independent third party and the results are public. The code compliance is certified and re-certified every three years.
 - There are nine principles and thirty one Standards of Practice.
 - The nine principals include; production, transportation, handling and storage, operations, decommissioning, worker safety, training and dialogue. Actions taken by KCGM to meet these requirements were presented for discussion.
 - Barrick and Newmont are signatories to the Code and KCGM is certified compliant since 2008.
 - KCGM is developing an Information Sheet for and will provide to the CRG in the near future for comment prior to public release.

Social Responsibility (Michelle Berryman) Community Relations Update:

• In March, KCGM had 33 recorded public interactions, 6 were complaints: Blast Damage (1), Dust (2) and SO₂ (3).
