## General Manager's Update (Russell Cole)

- Overview of performance for the second quarter of 2013.
- Safety:
  - Total of 5 injuries and 5 high potential incidents.
- Environment and Social Responsibility:
  - One million man hours reached without a Lost Time Injury (LTI). The \$10,000 bonus donated to the Goldfields Women's Refuge.
  - Super Pit Shop and Hannan's North Tourist Mine: fundraising activities planned and new merchandise at the shop.
  - Currently planning for the Mount Charlotte 50th Birthday celebrations.
- Physicals:
  - Open Pit is currently ahead in material moved, slightly down on ore tonnes.
  - Mount Charlotte is continuing to perform well.
  - Gold Recovery is slightly down.
- Vital Behaviors:
  - Rolled out to all KCGM employees and contractors across site.
  - The aim is to identify the behaviors required to improve safety.
  - Commitment sessions being conducted.

# **Environment Reporting (Michelle Berryman)**

- Noise:
  - KCGM has reapplied for a Noise Regulation 17 Variation for the Fimiston Operations...
  - Stage 1 Truck Noise Amelioration Project with the UWA is nearing completion and has identified the
    potential for a reduction in muffler noise. The Stage 2 federal funding grant by UWA was denied in July
    2013, though KCGM will continue its support of the project.

# Social Responsibility (Jacqui Niemand)

### **Activities in June:**

- 2 Donations and 1 Grant approved in June with a total value of \$2,455.
- KCGM had 41 recorded public interactions, including 2 complaints: SO<sub>2</sub>(1), and Staff Behavior (1).
- Over 8,000 unique visitors visited the KCGM website in June.
- Hannans North visitor numbers have increased with more tourists in the region.
