5. MINUTES

7. AGENDA ITEMS

Extension to Underground Mining (Ian Butler and Michelle Berryman)

- KCGM has identified an underground resource called 'Hidden Secret', due to its proximity to historic open pit and underground mining operations.
- The ore body is located east of Williamstown. Mining will be between 215 and 440 metres below surface, with the deeper operations located under some properties in Williamstown.
- The resource is estimated to be around 76,000 ounces of gold which will extend underground operations by around 2 years and create 11 new jobs.
- In September 2014 KCGM commenced stakeholder engagement and developed an Information Sheet for the project. Correspondence has been with Williamstown Residents, local government and industry groups and state government agencies. Some feedback has been received and is being considered as part of the project plans being prepared for the statutory approvals process.
- Recent media around the Hidden Secret Project and Life of Mine Planning was also discussed with the CRG.

Environment Reporting (Michelle Berryman)

- Notable Incidents:
 - Three dust events above the NEPM standard. Regulators advised. Two were regional dust events and it is likely that KCGM was the primary contributor for one. Operations were modified and water carts used to suppress dust.

Social Responsibility (Michelle Berryman)

Community Relations Update:

- There were 27 public interactions recorded in August, including three complaints: Dust (1), SO₂ (1) and Blast Damage (1).

Complaints and Property Inspection Management (Michelle Berryman):

- Complaints and property inspection process was discussed with the CRG.
- One unresolved blast damage complaint was extensively discussed after it was referred to the CRG for advice on further action.
