5. MINUTES

Minutes of the meeting held 8th May 2014 were approved unanimously by the CRG members.

6. BUSINESS ARISING FROM MINUTES

7. AGENDA ITEMS

General Manager's Update (Russell Cole)

- Safety:
 - One Significant Potential Event (SPE) in June.
 - A PC 8000 face shovel was working on the Golden Pike Cutback in the Fimiston Open Pit when its tracks slumped into an area of subsidence.
 - The face shovel was walked out of the void and returned to work following an inspection, no one was injured.
- Full Potential:
 - The program is in early stages and aims to improve cost-efficiency and help secure KCGM's longterm future.

Environment Reporting (Michelle Berryman)

- Notable Incidents:
 - One groundwater incident with a monitoring bore at Kaltails shallower than 4m below ground level.
 Reported to the regulator and primarily related to well above average rainfall, KCGM is increasing pumping capacity in this area.
 - One dust incident above the NEPM standard. Regulators advised, unlikely that KCGM was the primary contributor.
- Noise Regulation 17 Application:
 - The Department of Environment and Regulation (DER) released the Environmental Protection (Noise) Amendment Regulations 2013 in December 2013.
 - The changes to Regulation 11 reduced the allowable noise levels by 5 decibels (dB) at 4 KCGM blast monitoring sites.
 - Regulation 17 allows for variation to the prescribed standards.
 - KCGM has engaged a consultant to technically review the impact of these changes on operations.
 - A Regulation 17 Variation application for airblast was submitted on the 6th March 2014 to the DER.

 Supporting documentation related to this Regulation 17 Variation is being finalised, slightly behind schedule.

Social Responsibility (Peta Jurgens)

Community Relations Update:

- The KCGM 25th Anniversary Book is tracking along well.
- In May there were
 - 58.5 hours of volunteering, valued at \$2,925.
 - 54 media reports; 20 positive, 34 neutral and 0 negative.
 - 34 recorded public interactions, 4 were SO₂ complaints.

- Now opening on Public Holidays.
- Increasing support from local businesses donating services, equipment and materials for specific projects.

Hannans North continues to grow and develop into an important tourist attraction for the region. Feedback from visitors is very positive. Work continues on the development of business plans and establishing a "not for profit" organisation for the benefit of the City of Kalgoorlie-Boulder.
