7. AGENDA ITEMS

Social Responsibility (Peta Jurgens) Community Relations Update:

- Two donations approved in November with a total value of \$712.00
- KCGM had 26 recorded public interactions, 3 were complaints: Blast Vibration (1), Dust (1) and Staff and Contractor Behaviour (1).
- The St Barbara's Festival was a great success in December with Margaret Woodley as the KCGM Christmas fairy.
- Hannans North Open day was a success and the day also launched the new opening hours and entry fees for Hannans North, 170-180 people attended.
- The KCGM Christmas Parties and Awards Presentations went well.

KCGM Perception survey Update:

- The report for the KCGM Perception survey was received, 50 surveys were completed.
 Questions were in the areas of Engagement and Communications, KCGM in the Community, Environmental Management, Employment, Mine Planning and Closure.
- The 2014 Stakeholder Engagement Plan has included actions based on the recommendations, which identified a need for increased awareness through advertising and written communications around:
 - Blast times and the meaning of 1 hour's notice
 - Community Reference Group
 - Public Interaction Line
 - Closure plans
 - KCGM Community investments, particularly Hannans North

CRG Guidelines Update (Graeme Smith):

- Updates to the CRG Guidelines were discussed with potential changes suggested:

 - Outline processes for ending membership more clearly
 - Add CR Coordinator contact information
- Overall the updated CRG guidelines were accepted pending suggested changes.

MS advised that the opening hours on the sign at the entrance of Lookout need updating. MG asked about signage that gets put up when the Lookout is closed for blasting. TS clarified that the Lookout is only closed for maintenance, bad weather conditions for safety, relevant signage in place.

TS asked if we could have the CRG profiles updated at the Lookout. TS advised that old signage will be taken down during January and new signage put up once Chair and members elected.
