General Managers Update (lan Butler)

- Safety review:
 - One recordable injury and no SPE's or HPI's in November.
 - A very strong focus on safety over the past month and this will continue over the holiday period.

Environment Reporting (Michelle Berryman)

- Notable Incidents:
 - One dust event above the NEPM standard. Regulators advised, KCGM not a contributor.

Closure (Michelle Berryman)

- Mine Closure Plans must be submitted every three years; next submission is due in March 2015.
- Includes Fimiston, Mt Charlotte, Gidji Processing Plant, Mt Percy and regional infrastructure.
- 2015 submission has been revised to include 2014 Life of Mine Plan.
- KCGM's closure priorities: Public Access, Rehabilitation, Visual Amenity, Social Impacts of Closure and Stakeholder Engagement.
- The KCGM Community Reference Group is encouraged to continue to provide feedback.
- KCGM continues to look for opportunities to extend the Life of Mine (LOM).
- LOM plans are subject to change due to economic conditions.

Social Responsibility (Michelle Berryman)

- The KCGM Excellence Awards were presented to KCGM employees in the categories of Continuous Improvement, Environment, Safety Champions, Volunteer of the Year and Core Values Winner of the Year. There was also a presentation to the ER Team by Tony Stephenson on behalf of the CRG.
- The St Barbara's Parade was a great success, and well attended by KCGM volunteers.
- The KCGM Christmas Parties were held in November and December.
- \$1,844 was raised across site for the 2014 Salvation Army Christmas Hamper Appeal.
- CRG Survey conducted in November. Feedback included:
 - Key focus areas in the community are: Employment, business development and economic impacts, environmental impacts, education, family community atmosphere, stable population and multiculturalism.
 - The KCGM complaints procedure is effective.
 - All are satisfied with current monthly meetings at midday.
