7 AGENDA ITEMS

General Manager's Update: (lan Butler)

- KCGM storm event:
 - On Friday 4th December KCGM received significant damage to site from a weather 'micro burst' which included hail and strong winds.
 - Damage was caused to the heavy vehicle maintenance workshops, Open Pits, trees, fences and general areas across site.
 - · Assessment and clean up has begun.
 - Demolition and reconstruction of the workshop will occur over the coming months.
 - WD noted it was a good decision to publish the photos of the storm damage. MG agreed, based on positive feedback he had received from community members.

Safety:

- One Significant Safety Incident during October.
- Discussion of the movement of the Ball Mill. Detailed investigation has been completed, root cause and actions discussed.



Social Responsibility (Jacqui Niemand)

- Clean Up KCGM Day and Newmont Executive Leadership Team visit went well during November.
- KCGM Excellence Awards, Christmas Parties and St Barbara's Festival were a great success.
- A VIP tour for the Federal Minister for Resources and GEMG Gidji Tour were held during November.

Social Impact Assessment Update (Jacqui Niemand)

- This is the fourth SIA conducted by KCGM to gauge public perceptions about the operation.
- The assessment is tracking well with the Internal Working Group meetings, CRG workshop, Stakeholder Interviews, Data collection and Community Telephone Survey's all completed.
- The first report has been received by KCGM, some key findings that include:
 - KCGM has a substantial positive impact on Kalgoorlie-Boulder and enjoys strong community support.
 - A key concern is how the community will be impacted as the mine reaches closure and how this is being communicated in the short term.
- Key recommendations are:
 - o To keep exploring and to keep operating and
 - Communicate effectively
- The final report is due in January 2016.
- The recommendations and key findings that will inform a Social Impact Management Plan to assist KCGM in guiding and developing strategic plans for the next five years.
- CRG Survey conducted in November. Feedback included:
 - Key focus areas in the community: Life of Mine, employment and economic impacts, environmental impacts, family community atmosphere, stable population, multiculturalism, cultural diversity and community participation.
 - The KCGM complaints procedure is effective.
 - Suggested future projects for support are: Life of Mine extension projects, Hannans North Tourist Mine, Loopline, mental health initiatives and rehabilitation of old mine sites.
 - Most important mine site closure aspects are: Rehabilitation and revegetation, leave site in near-current state for heritages and tourism purposes.
 - Majority are satisfied with current monthly meetings at midday.
