7 AGENDA ITEMS

General Manager's Update: (lan Butler)

- KCGM rock fall:
 - On Monday 25th January there was a 100,000 tonne rock fall on the West wall in the Open Pit.
 - The rock fall blocked the X ramp which is the primary exit point from the pit.
 - At the time operations were on a red lightning alert and no work was being conducted.
 The wall monitoring radar alarmed one hour prior to the slip occurring. There were no injuries.
 - The ramp was re-opened within one week of the slip occurring. It will take an additional five to six weeks to remove the slip material.
 - · Assessment and clean-up of the ramp has begun.

- Overview of performance for the fourth quarter of 2014:
 - Safety:
 - One Lost Time Injury (LTI), two Restricted Work Injuries (RWI) or Medically Treated Injuries (MTI) during the quarter.
 - Two Significant Safety Incidents occurred during the quarter.
 - Physicals:
 - Open Pits above budget on material moved which has exceeded the year to date budget.
 - Ore tonnes slightly down year to date, however head grade is good.
 - Mt Charlotte tonnes mined were on budget.
 - Processing tonnes milled is slightly below budget.
 - Overall 2015 was above budget on recovered and shipped ounces.
 - Financials:
 - Slightly behind budget across site.
- KCGM 2016 drilling:
 - Drilling has commenced by a drill rig positioned at the end of Outram Street, Boulder.
 - Part of a 12 month exploration program in the area, the drill rig will be at that location for approximately six months, and is expected to reach depths of more than 1500 metres.
 - Further drilling is due to commence at Mount Charlotte commencing in March 2016.
 - A drill rig will be positioned above the existing underground operations; at the northern end
 of the Glory Hole and within the Mt Charlotte core yard. The drilling here is expected to
 take eight weeks.
 - KCGM will continue to ramp up efforts to extend the life of mine with surface drilling throughout 2016.

Social Responsibility (Jacqui Niemand)

- \$720,041 was contributed to the Kalgoorlie-Boulder community in 2015 via donations, site tours, safety bonus, scholarships, volunteering and the Community Investment Programme.
- Hannans North update:
 - In 2015; the Indian Pacific returned, a new gift counter, signage and fencing was installed. The Underground Mine Experience and wedding venue packages commenced.
 - In 2016; the Hannans North website was launched, three new exhibits will be opened and project to assess the viability of reopening the underground mine continues.
- There was a decrease in complaints registered with KCGM in 2015.

2015 Annual SGMP Audit (Janine Cameron)

- The Seepage and Ground Water Management Plans (SGMPs) detail KCGMs' management of seepage at the Fimiston and Kaltails Tailings Storage Facilities (TSFs).
- Each year an independent auditor reviews the SGMPs.
- The CRG was asked to review the report and provide feedback, to be incorporated into the final report.
- The audit identified that objectives were met, with the exception of the pond sizes at Fimiston and Kaltails which were found to be substantially compliant.
- KCGM has already implemented management changes so that the current pond sizes are compliant and no further actions are required.

CRG Nominations (Jacqui Niemand)

- Two nominations were received for new CRG members.
- The CRG moved to review the CRG membership guidelines and application forms before approving any new member applications.
- This was agreed unanimously.
