7 AGENDA ITEMS

General Manager's Update: (lan Butler)

- Overview of performance:
 - Safety during November:
 - There were nil Lost Time Injuries, nil Restricted Work Injuries and nil Medically Treated Injuries in November.
 - Year to date there have been 8 injuries.
 - KCGM have passed the 2 Million Man Hours Injury Free. This allows a \$24,000 community bonus which is currently being voted on by the workforce.
 - Physicals and Costs:
 - Operating Financials slightly over budget.
 - Underground ore tonnes are in line with budget and tracking well.
 - Mill throughput, Open Pit and total movement are above budget.
 - Ounces produced are also tracking above budget.
 - Overall year-to-date is tracking well and we expect to finish 2016 above budget.
