7 AGENDA ITEMS

General Manager's Update: (Jarrod Riley)

- Quarter 1 workforce safety video was shown to the CRG members.
- Overview of performance:
 - Safety during April and May:
 - There were two Lost Time Injuries (x1April and x1May), nil Restricted Work Injuries and nil Medically Treated Injuries.
 - Physicals:
 - Open Pits were in line with budget, however material and ore mined was down.
 - Head grade was in line with budget.
 - Mt Charlotte grade above budget, however tonnes moved are in line with budget.
 - Processing tonnes milled below budget.
 - Financials:
 - Cost per ounce above budget due to less ounces produced.
 - Overall costs are tracking in line with budget YTD.

KCGM Rock Fall Update: (Jarrod Riley)

- On Monday 27th March there was a 120,000 tonne rock fall on the West wall in the Open Pit.
- Assessment of the failure and remediation plan has been completed and submitted to the DMP and to the OEPA.
- There are two phases to the remediation; cut back and tidy up.

Fatigue Monitoring Technology (FMT) Update: (Jarrod Riley)

- Five of Newmont's top fatality risks involve vehicle interaction.
- In 2016 KCGM conducted fatigue awareness and education with truck drivers.
- FMT is an engineering control which detects and alerts drivers of potential fatigue.
- Caterpillar's Driver Safety System (DSS) has been chosen by Newmont as preferred technology.
- The DSS will be installed in surface haul trucks at KCGM during the second half of 2017.

Human Resources department update (Peter Danks/Jadey Jackel)

- Inclusion and Diversity:
 - In 2017 KCGM are focusing on Inclusion and Diversity including Aboriginal and Torres Strait Islander and Female participation in the workforce.
 - There has seen a significant increase in ATSI participation which is currently trending above 5%.
 - Female participation at KCGM is tracking very well.
 - There has been an increase in recruitment volume in 2017 compared to 2016.
 - Residential commitment and trainee roles continue to be a big driver in the community.
 - KCGM is continually strengthening relationships with the local Aboriginal Workforce Development Centre.
 - The Human Resources department is also actively participating in key career events such as the ATSI Sundowner and Goldfields Girl.
 - A key focus is on removing barriers such as reviewing mandatory role requirements and residential status requirements.
 - A group selection process has been implemented for large recruitment processes.
 - Newmont Ethics Solution Tool and the KCGM Code of Conduct are available to all KCGM employees and contractors via the KCGM intranet page.

Sustainability and External Relations update (Wendy Mathews)

- Notable Incidents:
 - No complaints were received during April and May.
 - Seven complaints have been received YTD.
- · Inclusion and Diversity:
 - As part of the ATSI and Female Participation focus in 2017, a Business Resource Group (BRG) has been formed.
 - The role of the BRG is to improve the diversity and inclusion of Newmont and KCGM.
 - The BRG is open to and comprised of KCGM employees.
 - There are three focus groups in the BRG; ATSI, Women in Mining and Parental support.
- Events:
 - The official opening of the new Cassidy offices at Mt Charlotte was held during May.
 - On the 17th June there will be a free community open day at Hannans North Tourist Mine to celebrate 60M ounces of gold poured from the Golden Mile, 20M ounces of gold poured at KCGM.
 - Commemorative medallions are being produced for both milestones.
