7 AGENDA ITEMS

General Manager's Update: (Jarrod Riley)

- Overview of performance:
 - Quarter two workforce safety video was shown to the CRG members.
 - Safety during July:
 - There was nil Lost Time Injury, nil Restricted Work Injuries and nil Medically Treated Injuries.
 - Physicals:
 - Open Pit movement below budget due to exclusion zone following the wall failure.
 - Mill throughput in line with budget.
 - Mt Charlotte ore slightly behind budget.
 - Financials:
 - Underground and Mill unit costs above budget, Open Pit unit costs slightly below budget.
 - Capital under budget due to timing of projects.
 - Cost per ounce above budget due to lower ounces produced.

Life of Mine Tailings Strategy Update: (Bria Whiter)

- Tailings are the major waste product from the treatment of gold ore. A mixture of fine solids, process water and reagents. KCGM have four TSF's.
- KCGM have both regulatory and corporate requirements to safely store tailings within our Tailings Storage Facilities (TSFs).
- Projects are currently underway to create additional capacity to meet KCGM's Life of Mine (LOM) requirements. These projects include:
 - Fimiston I height increase to 60m has been approved by the DMP, license amendment underway
 - Kaltails height increase to 60m, a detailed design is in progress
 - Extension to Fimiston II TSF, a prefeasibility design is in progress
 - Gidji additional tailings study options are in progress.
- All TSF designs have been completed in accordance with regulatory requirements by qualified Geotechnical Engineers.

Dewatering Project Update: (Mariano Mariano)

- Dewatering of the Fimiston Open Pit is required to approximately -70m below the current planned pit shell in advance of mining.
- The dewatering will allow access to ounces in the Golden Pike and Morrison layback areas, ensure that the groundwater level is in excess of 30m below the pit floor and will sustain capital investment.
- There are two phases to the dewatering project: Chaffers pump upgrade (which was completed in July 2017), and the installation of two new dewatering bores on the southwestern side of the Fimiston Open Pit.
- Opportunity to realign the footprint of the Trafalgar WRD to ensure future construction and rehabilitation activities will not impact the dewatering pipeline.

Sustainability and External Relations update (Jarrod Riley)

- West Wall Remediation:
 - First blast occurred on Friday August 4 at 1pm.
 - Letter drops sent to local residents on Johnston St and Johnston St East residents asked to vacate during the blast.
 - There are approximately two more blasts scheduled over the next 2-3 months.
- Community Investment Programme:
 - KCGM have confirmed \$3,000 platinum sponsorship of the 2017 City of Kalgoorlie-Boulder Art Prize to be held September 9th to September 25th 2017.
 - The 4 Million hours LTI Bonus recipients were announced (\$11,040 PCYC and \$36,960 to the Kalgoorlie Hospital).
