Responses to CRG feedback:

Feedback/Question	KCGM Response
Provide a response to the group regarding rehabilitation to the area to the south of the existing waste dumps.	KCGM currently holds the tenure over the western side of this historic tailings dam footprint area (tailings dams were reprocessed by a State Agreement in the past), but not the area around the old Lakewood town site. Prior to considering rehabilitating this area, KCGM needs to understand the geochemistry of the soil and variability over time (years), with wet and dry periods. In 2015, KCGM installed monitoring bores in the area to collect this data. Unfortunately, we haven't had enough significant wet weather events to collect enough data to make a decision. We had a significant rain event a month ago and samples have been taken. However the overall process is not quick, requiring time series data with high and low rainfall periods.
